Communicate our vision with all employees and business partners. This includes our policies on the issue of modern slavery and human trafficking.



Operating in accordance with globally recognised industry standards, and the law.



Directly pay our employees, not using an agency or third party.



As much as possible, we recruit our talented employees directly, again negating the need for an agency or third party.



Employ and nurture local talent to support our local community and the area to which we owe so much.



Risk Assessment

We have assessed our business for the potential risk of modern slavery and human trafficking. The two key areas that require consideration are within our own workforce, and within the supply chain.

Our workforce

We consider that the potential for the risk of modern slavery and human trafficking within our own workforce is very low. This is because of our robust employment and operating practices that ensure we are as diligent as possible.

Across our workforce, only 2% are not directly recruited by AP Mitchell, and the outstanding individuals who come to us from an agency do so from a trusted organisation who have their own due diligence procedures and hold similar work values to ourselves.

The supply chain

We consider that the potential for the risk of modern slavery and human trafficking within the supply chain to be higher than within our own workforce.

Acknowledging this as a building services company we must therefore be vigilant. To mitigate this risk, we use suppliers that align themselves with our core values, or who have been vetted by an appointed contractor for whom we are operating.
